**US Marshals to hold media day on Wednesday, Oct. 23, at Golden 1 Center to showcase cars from an upcoming auction  
Sample from largest single-owner car collection ever auctioned by the U.S. Marshals on display at DOCO (Downtown Commons)**

Preview 10 select cars from the largest single-owner car collection ever auctioned by the U.S. Marshals on Wednesday, Oct. 23, outside the entrance of the Golden 1 Center. Check out the 1978 Pontiac Trans Am owned by Burt Reynolds, a replica of the car he drove in "Smokey and the Bandit." See below for the details of the nine other vehicles on display.

The 149-car collection from a federal civil case involving the owners of the now defunct DC Solar company includes classic, performance, and luxury vehicles. The auction will be held Saturday, Oct. 26, in Woodland, California.
